GUIDELINES FOR PREPARATION AND SUBMISSION OF MANUSCRIPTS TO

AJEA

1. Manuscript should be original, clearly and precisely presented in English (preferable double space and saved in Word Documents).
2. Each submission should not be longer than 6800 words (16 printed pages) in total, including title, author(s) information, Tables, Figures, and References. Each article should be accompanied by an abstract of approximately 200 words typed on the separated sheet. Preparation of Manuscript: **AJEA** adhere to a rigorous double-blind reviewing policy in which the identity of both the reviewer and author are always concealed from both parties.
3. Author(s) assign copyright to Benchmark Educational Services.

- v. After payment of the publication/process fee, send us scan copy of payment proof for further process.

PAPER TEMPLATE

As part of the submission process, authors are required to check off their submission's compliance with all the following items and submission may be returned to authors that do not adhere to these guidelines.

1. The submission is written in English without technical terms and jargons
2. Cover sheet should contain title, full name, institutional affiliation, address, phone and email address.
3. Text should be type with double line spacing, 30mm margins and 12 font size Times New Roman. It must include abstract, keywords, background, research problem, objectives, literature review/theoretical framework. Methodology must be written in prose and not with sub-headings, data discussions and policy recommendations.
4. References should strictly follow the current APA format.
5. Tables should be self-explanatory and inserted where it is supposed to appear in the body of the paper.
6. An abstract of 250 words is included for articles
7. The author(s) profile is complete and updated

Galley proof will be sent to the corresponding author. The author(s) are responsible for reading the galley proof.

PUBLICATION ETHICS AND PUBLICATION MALPRACTICE STATEMENT

These guidelines (Code of Conduct and Best-Practice) as enacted by the Committee on Publication Ethics (COPE) in 2011 are adopted by Benchmark Journals to define the responsibilities of Authors.

Responsibilities of Authors

1. By Submitting Manuscripts, authors attest that the manuscript, wordings and ideas are their original work and not lifted from other sources without appropriate citation or quote.
2. Authors are responsible for writing and obtaining permission for images or other artworks used in the research. The copyright holder must be made explicitly aware that the image(s) or artwork will be made freely available online as part of the article under a Creative Commons license. This license allows the benchmark journals to retain the copyright, but also allows others to freely copy distribute and display the copyrighted work.
3. Authors should not submit manuscripts that have already been published or being reviewed for publication.
4. An author should not submit manuscript with same research in multiple journals. If such behavior is discovered, the manuscript under consideration will be rejected, or if already published, such article will be retracted.
5. If an author discovers an error or inaccuracy in an article that has been published in Benchmark Journals, he or she is obliged to notify the editors and work closely with them till the error is correctly. If the error is significant and cannot be corrected without altering the entire work, the article should be retracted.
6. Authors' names should be listed on the article and each author should take responsibility for his contribution.
7. All sources of financial and academic supports should be acknowledged in the manuscript.
8. Authors must clearly state references in the manuscript with the explicit permission for others to replicate the work.
